I am writing to congratulate your child in reaching the level of Achievement Points in the Academy which has earned them a place on the Academy’s Christmas reward trip to Winter Wonderland in Hyde Park, London on Thursday 08 December 2022.

We will be travelling by coach and students will need to meet at the Academy at 07:45 am ready for a prompt departure. We aim to return to the Academy by 3.00 pm (traffic permitting) when students will be dismissed. Students do not need to wear uniform; however, they will need to wear warm, comfortable clothing, including suitable footwear and a waterproof warm jacket. They will also need to either bring a packed lunch or money to buy food. Those entitled to free school meals will have a packed lunch provided for them.

The majority of the expenses have been covered by the Academy, however, students will need contribute £6.00 towards the cost of travel. This can be paid in via ParentPay. Students will need to book activities like ice-skating at Winter Wonderland themselves if they wish to do so.
